VENDOR TERMS & CONDITIONS

BOOTH INFORMATION: Each space is 6' table and will be clearly marked. The booth fee is \$150 or \$200. Payment must be submitted with the application. No refunds will be provided for cancellations received after January 28, 2010. Bobbi Jo Palmer Events assesses a \$25 fee for returned checks. Out & About Magazine has the right to prohibit and/or evict (without refund or assumption of liability for lost sales or expenses) any presentation or person who is in any manner deemed offensive or unprofessional. Vendors must provide their own display and must conform to the assigned space.

SELECTION: Space is limited. Selections are made based on date received and duplication of items. Applications and payment must be received in the Out & About Magazine office or by mail to P.O. Box 276, Gilroy, CA 95021 by the deadline date of February 1, 2010. Any applications received after that date will be charged a \$50 late processing fee. Your applications will be reviewed in order received and you will be notified of your acceptance. Two weeks before the event you will receive a Faire map with booth location and further vendor instructions. If not accepted, all materials and fees will be returned promptly. **NO REFUNDS!** Every effort will be made to accommodate special requests and are not guaranteed. All placement decisions are final and will not be negotiated.

REGISTRATION: Donuts & Coffee will be available at 9 am at registration on Sunday, February 28th, 2010. If you have not shown up by 11:00 a.m., you will be deemed a no-show, without refund, and the adjoining booths will absorb your space. All booths completely set up and ready for business by 11:30 a.m.

SET-UP: Please drop your booth equipment and merchandise off at your booth space and proceed directly to vendor parking and registration. Your space must be completely set up by 11:30 a.m. and open for business by 12 pm.

TEAR DOWN: All vendors agree to participate for the entire event and understand that tear down before 5 pm on Sunday is not allowed for any reason. At the conclusion of the Expo, all vendors are required to be completely torn down by 6 pm.
